01. Technical Support provision


Regional Technical Support Hub for Eastern Europe and Central Asia (RTSHub, RTSH, EECA Hub)





The technical support areas include, but are not limited to: Policy and advocacy, Community mobilization / civil society strengthening, Treatment, care and support, Behavior change programmes, Health and community systems strengthening, Governance, management and human resources, Strategic and operational planning, Assessment and research, Monitoring, evaluation and reporting systems, Resource mobilization, Financial management.

The Regional Technical Support Hub for Eastern Europe and Central Asia (RTSHub, RTSH, EECA Hub) provides long- and short-term sustainable technical assistance (TA, TS) based on best practices to non-governmental organizations / community-based organizations / umbrella organizations, coordinating bodies, including Country Coordinating Mechanisms (CCMs) / governmental organizations, UN agencies and private sector organizations

Key projects

LinkUp

a long-term (3.5-year) project of establishing and harmonizing monitoring and evaluation systems in five countries: Bangladesh, Burundi, Myanmar, Uganda, Ethiopia and adapting SyrEx software to adjusted to local contexts. One more big achievement is the development of a unique clients registration code and the program's implementation in coordination with all country stakeholders. During project implementation, we developed capacity of over 100 people from among M & E staff of a number of local organizations to create a comprehensive and robust M & E system in their organizations. The implemented M & E approaches were replicated and scaled-up over other projects which will ensure sustainability of project outcomes.

Harm Reduction Academy

is a global learning, dialogue and skills building course established with the vision to end AIDS and Hepatitis C among people who inject drugs. We conducted 2 Cycles of Academy (Kyiv, Ukraine and Deli, India) and brought together 30 individuals with a mix of international backgrounds ensuring professional and cultural diversity in the classroom and in the field.

03. Research

Alliance Consultancy has been engaged in several major research projects



2 researches were held in the framework of the METIDA project ('M&E-related Technical Assistance and Improved Data application in HIV' - a project funded by Centers for Disease Control and Prevention (CDC) under the United States President's Emergency Plan for AIDS Relief (PEPFAR) and being implemented by The International Charitable Foundation "Alliance for Public Health" for the period of 30 September 2012 – 31 March 2018):

MoT-Assessment of reported HIV modes of transmission in Ukraine

The research was planned for interviewing of recently reported HIV cases using enhanced instruments to further improve the estimates of prevalence of HIV risk factors (IDU, MSM, providing or using commercial sex) and consisted of 2 parts: qualitative and quantitative parts.

Qualitative research part: recruited 42 health care providers, 29 for 4 focus groups conducted in 4 cities, 13 for in-depth interviews; technical and qualitative reports were prepared.

Quantitative research part: 9 teams in 8 cities were hired and trained, 2328 randomly selected HIV positive patients (enrolled into care in 7 regions of Ukraine during 2013-2015) were interviewed. Technical and qualitative reports are being prepared, report to be printed in 2017.

Integrated Biological and Behavioral Surveillance (IBBS) Survey among PWID and their sexual partners

Report on National representative Integrated Biological and Behavioral Surveillance (IBBS) Survey among PWID and their sexual partners (9405 PWID and 769 partners were interviewed and tested in 2015) is published: aph.org.ua/wp-content/uploads/2015/09/Monitoryngpovedinky-SIN_PROEKT.pdf

Purpose: to track the changes and tendencies in HIV spread and receipt of information on potential behavioral factors related to HIV transmission in the population among key groups to use it in information sharing and advocacy activities, planning, monitoring and evaluation of prevention programs' effectiveness.

Objectives: evaluate/assess HIV, hepatitis B and C and syphilis prevalence among PUDs and their partners, their behavioral patters, connected to HIV-infection, drug use, usage of HIV prevention and treatment services and HIV in these two groups.

Country, place:

PUD research: Ukraine, 29 cities/towns; 25 administrative centres and the Crimea, in Sevastopol and 3 cities of Kyiv Oblast.

PUD partners research: 10 towns/cities.

A Study of Networks, **Recruitment and HIV** Risks among PWID in Kyiv, Ukraine

Country: Ukraine

Organization of preparation and conducting, as well as logistical support of interviewing respondents within the K01 research project.

Purpose: to design and implement a Respondent Driven Sampling (RDS) pilot study that would serve as an improvement over the current RDS sampling scheme in the study of HIV and HCV transmissions.

Activities: For this purpose 500 PWID were recruited by RDS, interviewed an tested on 1st wave in December 2015 – April 2016 and 250 randomly selected participants of 1st wave were recruited again, interviewed an tested on 2nd wave in September - December 2016.

Aim: to increase the professional capacity of monitoring and evaluation staff, representatives of stakeholder and partner organisations, engaged in the implementation of research in HIV/AIDS sphere, analysts, medical workers and other representatives of specialized institutions around Ukraine. The events are directed and raising their awareness, developments of crucial skills for working with data, introduction of up-to-date approached to data analysis and new M&E instruments. Such events will allow to improve the overall process of data collection, aggregation, analysis and interpretation.
